### Important Update From the Building Corporation Board

As mentioned in the July 2014 newsletter, your alumni Building Corporation Board held two update meetings in May 2014 to discuss the success of the Gamma-Alpha Chapter and associated developments. The meetings were held at the Eugene Hilton and the Portland Multnomah Athletic Club. Two invitations for each were mailed, as well as e-mail notices where possible.

At the May 2014 meetings, it was proposed that a portion of the house sale proceeds be used to fund undergraduate scholarship and leadership awards. Alumni present at the meetings generally favored the concept. As a result, significant steps have been taken toward conversion of the Building Corporation to a scholarship-focused 501(c)(3).

First, contact was made with our National Headquarters to explain our intent. They encouraged us to pursue the concept. The board then approved hiring a Portland attorney specializing in the field of "not for profit public entities." His work has guided us in moving to a 501(c)(3) tax-exempt format. Given the attorney's detailed input, the board has voted unanimously to move forward with the change as soon as possible. The change will open the door for undergrad scholarships for Gamma-Alpha members, and will additionally allow "Tax-Deductible Gifts" from alumni! This represents a major improvement over our current structure. The scholarship program would be administered by our National Headquarters. Our new Gamma-Alpha 501(c)(3) will continue to locally control and hold all funds. Initially, only a small portion of our funds will be committed to the scholarship program, with intent to expand the format in the future.

The new 501(c)(3) structure will allow consideration of future property acquisition, when appropriate and when future conditions warrant that step. For multiple reasons, property acquisition has been put aside for the indefinite future.

Despite challenges faced by fraternities today, both locally and nationally, our chapter remains strong with approximately 70 members. Two extraordinary and dedicated alumni advisors continue to provide guidance: Kevin Sasaki and David Giles, both of Portland, have made many, many trips to Eugene over the past six years. Amazing!! Our young men are an outstanding

group, focused on the Four Pillars of Kappa Sigma: Fellowship, Leadership, Scholarship, and Service. Ritual proficiency remains at nearly 100 percent for the undergraduate members, a true sign of commitment!

It is worth noting that Greek life has seen a strong resurgence nationally, and the U of O is no exception. More than 16% of undergraduate students at the U of O now belong to Greek organizations, nearly double the percentage from 10 years ago. Our Gamma-Alpha Chapter is now one of the largest Kappa Sigma chapters on the west coast.

Nationally and locally, Greek fraternity and sorority organizations are going through significant changes brought on by social issues such as substance abuse and sexual conduct. Universities and colleges are mandating change, as are our alumni and our national organizations. The steps now being implemented toward a focus on scholarship are timely for Gamma-Alpha. Time has truly brought about change!

#### **Obituaries**

John Y. "Jack" Lansing, '39-486, of Wilsonville, Oregon, died October 28, 2014. Born in Portland in 1920, Jack earned his journalism degree at the U of O, where he was involved athletics and in politics, and served



as president of Kappa Sigma. After graduating, he attended graduate school at Stanford University and Norfolk College in England. In World War II, Jack was the squadron commander of a B-17 bomber group, and was a pioneer in drone warfare. John commanded the top secret mission Operation Aphrodite in 1944. Also in that year he roomed with President Kennedy's older brother, Joe, and was flying in the same formation with him when Joe's plane exploded over the English Channel, Jack was awarded two Distinguished Flying Crosses, four Air Medals, several battle stars, Theater Ribbons, and numerous citations for his exploits in air combat. He retired as a major. Jack was a director and officer of civic associations and four corporate boards of directors, including service as president of Pacific Power & Light Company and as chairman of Bohemia Corporation. He was a board member of the Eisenhower Library Association of Abilene, Kansas, Among his civic activities he served as chairman of the State Board of Aeronautics. He was one of the three founders of the Portland Duck Club (Oregon Club of Portland), and for over 70 years a passionate supporter of the U of O. Jack was the driving force in funding the Portland Trailblazers with Oregon sports scene leader and friend Harry Glickman at his side. He is survived by his son, John Jr.; two grandsons; and three greatgrandchildren.

Albert A. Prestholdt, '40-499, of Sun City West, Arizona, passed away in 2012 at age 91.

Malcolm H. MacEwan, '43-562, of Bend, Oregon, died June 17, 2012, at age 88.

James W. Ryel, '43-567, died November 17, 2014, in Surprise, Arizona. Born in 1924 in Long Beach, California, he completed his undergradu-



ate studies at the UO and took his Doctor of Medicine degree at the University of Southern California Medical School in 1950. Dr. Ryel and Dorothy Ann Seiler were married in Long Beach on August 19, 1947. Their daughter, Susan Lee, was born in 1949, and their son, James William, was born in 1952. Brother Ryel served in the Army for three years during World War II as an enlisted man, and for three years during the Korean War as a Medical Officer, attaining the rank of Captain. After specialty training in radiology at the USC Los Angeles County Medical Center, he worked as Chief Radiologist at St. Jude Hospital in Fullerton, California, from 1957 until his retirement in 1983. He was a member of many local, state, and national medical and radiological societies; he served as president of the Orange County Radiological Society and as a Fellow of the American College of Radiology. His hobbies included flying, motor racing (sports cars and desert motorcycles), and scuba diving, but golf and fly fishing were his true passions. Dorothy preceded him in death by just 45 days. He is survived by his children and by two grandchildren.

M. Arthur Stilwell, '43-576, of Honolulu, Hawaii, passed away on March 24, 2014. He was born in 1924 in Vancouver, British Columbia, and worked as an architect. He is survived by his wife, Norma Ann Stilwell.

Roy A. Hassman, '48-634, of Mesa, Arizona, passed away on July 25, 2014, at age 84, according to his family.

Irwin E. Joslyn, '56-767, of Blackfoot, Idaho, died August 13, 1995, at age 65. Thanks to Edward H. Stark ['57-789] for notifying the alumni office of Irwin's passing.
