This is the seventh year of GAEF scholarship awards. This year's awards totaled \$27,000. This is the largest amount awarded to date, and an increase from last year's \$19,000. Six scholarships of \$4,000 each were awarded to seniors Bridger Costello and Alden Felstiner; juniors Walker Dechant and Jordan Brewer; and sophomores Harrison Teague and Anthony Giannini. Three \$1,000 awards of merit were presented to juniors Jack Porter, Max Birch, and Andrew Slominski.

In addition, financial assistance is provided to officers attending regional leadership meetings and to a limited number of delegates to National Conclave. Since 2016, \$102,000 has been granted in scholarship awards alone.

Through generous alumni gifts and market performance, GAEF endowed assets have continued to grow significantly since inception in 2015. Our financial support means a great deal more today than ever to outstanding undergraduates, given the dramatic escalation in costs of tuition, books, and living expenses.

Many thanks are due to all who have contributed. A very special acknowledgement goes to Michael Orlando, who handles most of the time-consuming application process. He does an outstanding job of gathering and evaluating applications submitted. Thank you, Michael!

Take Advantage of a Tax "Loophole" . . . and Help GAEF Too!

If you are having to take your annual IRA Required Minimum Distribution (RMD) each year, a unique opportunity is available.

If you donate all or part of your IRA RMD directly to the GAEF, you get credit for taking the distribution, but you don't pay any income tax on it! The IRS allows you to instruct your IRA plan administrator to directly make the contribution to GAEF for you. You don't receive the funds, so it is not taxed as income. A \$1,000 distribution goes to GAEF as \$1,000, so you get credit for \$1,000 RMD and pay NO taxes on it!

Central Oregon "Father-Son" Legacy

A recent visit to Thomas Subaru of Bend, Oregon, brought together a remarkable story about Gamma-Alpha brothers Pat Thomas (1932-2013) and his son, Matt Thomas (1961–). Both men, in their own times, have been extraordinarily successful Central Oregon business leaders and auto dealership owners, with a family dynasty spanning more than 85 years.

Pat Thomas (Gamma-Alpha 1952) was born July 15, 1932 in Madras, Oregon. He was the son of William "Bill" and Loma Thomas. Bill opened the Shell Company Service Station and a Dodge-Plymouth

dealership (Madras) in 1937. Those businesses became the Thomas Sales & Service Company (T.S. & S. Co.) and remain such today.

Following high school in Madras, Pat studied at the University of Oregon, where he joined Gamma-Alpha. It was there that he met and married Joan Heartt of Gresham in 1952. They raised three sons in Madras. Pat was in Air Force ROTC at UO. Following his active duty, he retired in 1961 from reserve duty, a USAF Captain. His military experience and expertise focused on radar technology.

Pat followed his father, Bill, into the Madras-based family business. By 1977, Pat and Joan, working together, had grown the company to include six Dodge/Chrysler dealerships in central Oregon. Joan played a key role in management of T.S. & S.

Pat was highly regarded nationally in his industry, and served as president of the Dodge National Dealership Association. Pat eventually expanded into Subaru, building the large Bend dealership just east of Bend Central on Highway 20. Pat passed away in July 2013, followed by Joan in November 2019. Both were devoted UO alumni.

Today, Matt Thomas follows in his family's legacy, owning and operating the Bend Subaru and Madras Ford dealerships. Construction is well underway at the Subaru site of an entirely new complex of offices, showrooms, and a high tech service center. This is a multimillion dollar project which, when completed, will be one of the largest in the USA.

Matt, now 61, enjoys sharing stories of his youth and family as well as his business experiences. He grew up in Madras, graduated from Madras High School,

and began working with his family's business as a teenager. Matt has four children, including his son, Jake, who has joined the family business.

Attending the UO, Matt pledged Kappa Sigma at his dad's suggestion, and was initiated in 1984. Matt was a social activities coordinator for the chapter, and during his time in that role, many fun times were had. Matt acknowledged that those were some of his most enjoyable times! One story mentioned was about the "liberation" of two large concrete lions from the entry of a certain rival fraternity house. Apparently the lions "wanted" to go for a swim in the Mill Race!

Matt remains a devoted booster of the UO Athletic programs, annually making significant donations. Thomas Sales & Service Co. donates new automobiles each year for the University's use. As a season ticket holder and Duck Club member for many years, Matt regularly attends home and away games/events. In addition, Matt and T.S. & S. Co. contribute significantly to the Bend/Madras regional community needs, including "Every Child Central Oregon" and "Oregon Adaptive Sports."

All in all, this is quite a Gamma-Alpha legacy story. Thank you, Matt, for sharing!

Steve graduated from Sunset High School in 1967, where he was named "Friendliest Man of The Year" of his graduating class. Steve went on to U of O and joined Gamma-Alpha, where he made many great friends with whom he kept in touch throughout his life. Too many to list! He met fellow student Elaine Londer, whom he married following graduation. Steve went on to earn his law degree from Lewis & Clark, and also earned his CPA designation. He then

joined the law firm of Samuels, Samuels & Yoelin, which today is Samuels, Yoelin & Kantor.

Steve had a remarkable career, receiving many honors including the Oregon State Bar's Presidential Award, The Oregon State CPA Speaker of The Year Award, and Best Lawyer of The Year in Taxation. He made the list of Best Lawyers in America, and was a fellow of The American College of Trust and Estate Counsel.



Steve also gave much back to his wide community. He was a founding member and Past President of The Oregon Jewish Community Foundation and Past President of Jewish Family and Child Services.

He served as President of Ronald McDonald House Charities of Oregon and SW Washington. He was a member of the University of Oregon Foundation Endowment Committee, as well as committees of the Robison Home and the Fred Hutchinson Cancer Research Institute. He held board positions with numerous organizations, including The Nature Conservancy, Play It Forward, and too many others to list.

Steve played hard, was an excellent chef, and greatly enjoyed entertaining family and friends with

Norman K. Bishop, '47-598, died May 22, 2021, in Yachats, Oregon. He was born in 1926 in Salem, Oregon, and graduated from Beaverton High School, where he had been Student Body President. He then served in the Air Force as an airplane mechanic and typist. Following WWII, Norman attended the U of O and Portland State College, where he met Jean Evelyn Lumijarvi. They married in 1948 and settled in Lake Oswego. Norman began his career in automobile sales before switching to insurance with Northwestern Mutual, where he earned recognition as a member of the Million Dollar Roundtable. He returned to the auto business in 1966, as principal partner and president of Norm Bishop Volkswagen, Porsche, Audi, in Boise, Idaho. A lifelong Episcopalian, Norman helped establish William Temple House in Portland. He had an enduring appreciation for music, which he and Jean passed along to their five sons. Norman also enjoyed playing tennis and skiing. He was predeceased by his brother William ['47-599] and a son, Bartley. He is survived by Jean; sons Norman, Theodore, Gregory, and Jayson; ten grandchildren; and five great-grandchildren.

Allan E. Inglis, '47-607, passed away on April 15, 2021. Born in Seattle in 1926, he grew up in Dallas, Oregon, where he enjoyed horseback riding, fishing and hunting. He guided pack trips on the Pacific Crest Trail, and was a member of the Oregon Mounted Horse Posse. Allan became a world-renowned orthopedic surgeon at Hospital for Special Surgery (HSS) and double professor at Weill-Cornell Medical College. He received Lifetime Achievement Awards from the Arthritis Foundation in 2001 and the New York Society for Surgery of the Hand in 2013. The Allan E. Inglis MD Professorship in Orthopedic Surgery was established at HSS. While in medical school, he visited New York City for the first time and committed to make it his home. Soon thereafter he married Helen Elizabeth Uebel. After moving to Rye, New York, he and Helen joined the American Yacht Club. He is survived by Helen; their children, Allan, Jr., Jennet, Jamie, Steven, Captain Matthew, Vicki, and Suzanne; and six grandchildren.

Thomas Midgley IV, '55-757, of Santa Monica, California, died May 22, 2021. Born in 1935 in Columbus, Ohio, Thomas moved to Los Angeles in 1942. He graduated from Chadwick School,



where he was the football quarterback, led in track and field, and was lead golfer. He graduated from University of Oregon in 1958, where he ran the fastest recorded 100-yard dash during his freshman year. He graduated from the Navy's Officer Candidate School, and was commissioned an Ensign in 1959. He authored *From The Periodic Table to Production*, a biography of Thomas Midgley, Jr., the inventor of ethyl gasoline and freon refrigerants. Sandy, his wife of 54 years, predeceased him in 2017. He is survived by his children, Michael, Jennifer, and William, and three grandchildren.

Bret D. Hokkanen, '80-1236, of Portland, Oregon, died January 13, 2020. Born in 1960 in Portland, Bret graduated from Sunset High School in 1978 and Oregon State University in 1983, where he met



his wife Lin. Bret obtained his MBA in 1990 from The University of Portland and worked as an investment professional for the past 37 years, most recently as Director of Sales for Hood River Capital Management. Since childhood, Bret played tennis and golf and was an avid outdoorsman. Skilled at fly fishing and snow skiing, his love for the outdoors led him to serve on the Board of Directors of LEAP Wilderness Adventures. He also served on Committees for the Portland Golf Club and The Multnomah Athletic Club. He taught his sons to fish, golf, wakeboard, and ski at a young age. Bret is survived by Lin and sons Erik and Bryn.

Alexander S. Krafve, '15-1823, of Tualatin, Oregon, passed away



unexpectedly on November 19, 2021. Born in 1995, Alex attended the University of Oregon as a business major. He acquired an internship with the Athletic Department and led guided tours

of the football facilities for guests and dignitaries. He will be remembered for his beautiful engaging smile, artistic ability, subtle wit, and kind heart.
